- Knowledge of Indigenous values, communities, and instructional methodology, and experience working with Indigenous organizations and Indigenous adults
- Knowledge about assessment for learning and assessment of learning from an indigenous lens
- Experience navigating Moodle is a must
- Curriculum development and lesson planning are a priority
